There is a negative slope towards the rear of home. This area does not appear to drain water away from home and needs landscaping and drainage corrected.

The moisture level on the wall behind the negative slope is elevated. A qualified licensed contractor should repair as needed.

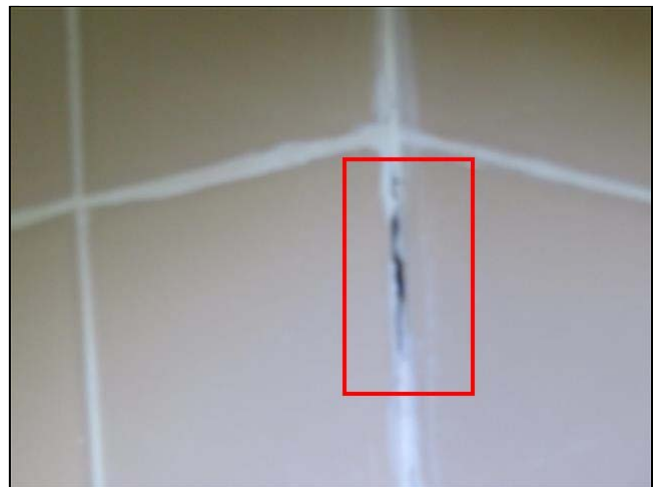
